
**TERMS AND CONDITIONS OF THE TENDER**

1. Sealed tenders for the articles shown for the Vidyalaya as shown above are invited by the Principal on behalf of the Navodaya Vidyalaya Samiti Ministry of H.R.D. Education Department, New Delhi up to 4 PM on 13.12.2018. Tenders should be sent under sealed cover marked as "Tender for the **PRINTING PAPER**". The tender will be opened in the office of the Principal, JNV Vechoochira at 11 AM on 14.12.2018
2. The tenders shall be submitted according to the terms and conditions specified otherwise in the tender, it shall be construed that the terms and conditions stipulated here under have been agreed to.
3. The rates should be including all the charges, including freight charges, Excise duties, sales tax, VAT or any other taxes.
4. There should not be any over writing or corrections in the tender. If a figure is to be amended it should be neatly scored out, the revised figure written above and the same attested with full signature of the tenderer with date. In the absence of the attested signature, the tender is liable to be rejected.
5. The undersigned does not bind him to accept the lowest tender and reserves the right to accept the tender in whole or in part.
6. On acceptance of the tender it will become a contract and the contractor, shall be bound by the terms and conditions of the tender.
7. The person/persons submitting the tender shall deposit an earnest money of Rs. 500/- in the form of Demand Draft in favour of "The Principal, Jawahar Navodaya Vidyalaya, Vechoochira, Pathanamthitta" payable at SBI Vechoochira along with the tender which shall be refunded in the event of rejection of the tender. **Earnest Money in the form of cash, cheque or in any other form will not be accepted.** The earnest money will be forfeited in the event of the failure to comply with the contract. In the event of the tender being accepted, the earnest money will be adjusted towards security deposit which shall be payable after completion of the contract period. If the contractor is not agreeable to pay the security deposit, the reasons therefore should be specified and the undersigned reserves the right to accept or reject the request.
8. The person/persons whose tender is accepted, hereafter called contractor, shall deposit an amount depends on the cost of items selected towards security deposit, details of PAN, Bank details for payment immediately on intimation from principal, JNV Pathanamthitta.
9. Samples should be attached with tender. The supply shall be as per the sample attached.

- 10. The rates quoted by the contractor shall hold good up to 30.04.2019. No amendment in the rate except increase in the rate of Sales Tax/VAT if any during the period of execution of the contract will be accepted.
- 11. The amount of Security Deposit may be retained by the Vidyalaya for a period of six months from the date of completion of the work.
